# PTA/PTSA



Established in 1924 and organized under the authority of the Florida PTA, the Hillsborough County Council of PTA/PTSA is a team of volunteers dedicated to strengthening local PTAs and PTSAs in Hillsborough County, helping them to work more effectively on behalf of the children in their schools and communities. Local PTAs and PTSAs join the Council as self-governing bodies, paying dues as prescribed in the Council Bylaws. As a local PTA or PTSA, the HCC PTA/PTSA is your direct line of support! Together, we form a strong, unified voice on behalf of the children in Hillsborough County.

# JOIN TEAM HILLSBOROUGH!!!!

One area that is often confusing to new Board Members is the hierarchy of PTA. You have National PTA, Florida PTA, Hillsborough County Council, and then the Local Units. That's pretty easy. It is at the Local Unit level that it can get confusing.

Your PTA is made up of three bodies: your General Membership, Executive Board, and Executive Committee. The responsibilities and who make up each of these groups is outlined in your Bylaws, and is typically as follows:

#### Your General Membership

Consists of anyone who has paid membership dues to your PTA this year. They must approve how you raise and spend money (i.e., your Budget), must approve your Bylaws (when they need to be renewed or amended), must elect a Nominating Committee each year to recommend officers for the next year, and must then elect the officers for the new year.

## A subset of this group is your Executive Board

The Board consists of your elected officers (President, Vice Presidents, Secretaries, and

Treasurer) AND the chairpersons of your standing committees, the Principal (or designee), and may include a faculty representative, and a student representative (if you are a PTSA). It is the governing body of your PTA. It is responsible for planning the programs and services provided by your PTA, preparing the budget to be presented to the General Membership, etc.

## <u>A subset of this group is the Executive</u> <u>Committee</u>

Is made up of your elected officers. The purpose of the Executive Committee is only to transact emergency business between Board meetings. If it's not an emergency, it should wait for a Board meeting.

## **Responsibilities of ALL Board Members**

Some board members are elected; they are the officers (President, Treasurer, Vice Presidents, etc.) Other board members will be appointed to serve as chairpersons. Whether elected or appointed, all board members must understand just what their responsibilities are.

Every PTA board member has a fiduciary responsibility to the PTA membership. What exactly does that mean? Well the dictionary defines fiduciary as "of, relating to, or involving a confidence or trust." The law imposes three duties of trust: duty of care; duty of loyalty; and, duty of obedience.

All board members must discharge their duties with the care of any prudent person in a like position. They must actively participate in the management of the organization which means attending meetings, evaluating reports, and reading minutes. If a problem develops, it is a board member's duty to inquire.

Board members must give their undivided loyalty to the association/membership and cannot put
